Re.: PAC N. California Division Annual Meeting

Dear Mr. Spula:

I must vigorously protest actions by Anthony Zukovsky seemingly under the auspices of the PAC National Office which completely misrepresent the final recommendations of the PAC Grievance Committee in San Diego in October 2006 as approved by the Executive Committee of the Polish American Congress.

I have tolerated these outright lies and misrepresentations long enough. Each and every message published on Waldemar Glodek's Internet pages of the Polish Club in San Francisco ([www.polishclub.org](http://www.polishclub.org)) and signed with Zukovsky's name (sample copy enclosed) was also sent to you. Neither you nor any other member of Executive Board to whom these messages have routinely been addressed expressed even a hint of displeasure or dissatisfaction with misinterpretations, misgivings and often, outright lies contained therein.

The Grievance Committee recommendations approved by the Executive Committee spelled out the specifics of the meeting. Nowhere there were any restrictions as to the picture identifications, requirements of having a hard copy of individual notification letters and other totally unfair, undemocratic measures indicated in Zukovsky's announcement. It is abundantly clear that Zukovsky continues to disregard the rules applicable to notices, annual meeting and composition of its leadership and other important provisions of the Division Bylaws. Even your own statement from the December 12, 2006 letter which stated, that it will be your office informing all members of the upcoming meeting, escaped his attention.

Please note that Zukovsky's announcement of the meeting on Glodek's Internet pages is specifically directed to all members as of July 9, 2006 and "eligible to vote". Not only this is unconstitutional but it doesn't comply with the statute. Division Bylaws do not discriminate between members in allowing only one group to participate in the Annual Meeting and keep other members out.

Furthermore, as of today, I have not received any copies of the PAC National Office verified membership list so that it can be compared and reconciled with the true membership list as it existed before the Division authorities under Mr. Zukovsky's leadership meddled with and altered to suit their needs. I am also concerned about the fact, that the newly accepted members (20 new applications approved by the Executive Committee) did not receive the invitation to the meeting, though the applications were in your office from early September 2006.

The time available to reconcile illegal alterations of membership rosters, resolve the rights of the newly accepted members the task of curbing Zukovsky's antics seems to indicate, that perhaps the meeting date is somewhat premature. It was not announced with appropriate advance notice so there is still an opportunity to change its date to properly prepare for it.

In conclusion, I urge you to uphold the Executive Board's decision as spelled out in your Dec. 12, 2006 letter: appoint and announce your Representatives to host this meeting and invite members from properly verified rosters. I also urge you to send me copies of that verified roster before the meeting. Anything else I will regard as your tacit support of Glodek - Zukovsky continuing policy of deceit and recklessness and as much as I have tried very hard to avoid even a hint of legal action, your lack of response will leave me no choice.
